## Annual General Meeting June 22, 2021 7 PM

At various times there were anywhere up to 36 people in attendance, comprised of Board members (both old and new boards). Staff, Committee members, Volunteers, Federation representatives, the Auditor, and friends. These minutes will go to the new Board and Staff reps to the Board. Again, all documents referred to should be available on your Google Drive.

**Greetings**: Hanna opened the meeting bringing greetings to everyone. She spoke lovingly of Carol Krames, indicating the great loss we all felt on Carol's passing, but indicating that inwardly, Carol was still with us.

Motion by Paul R, seconded by George C to approve the agenda as presented...passed. Motion by Gord, seconded by Carol to approve the minutes of last year's AGM as distributed (to the board), and passed.

**Annual Report**: Alexis went through her previously distributed Annual Report. The main theme of the report is that "We are Family". She thanked the current Board, showed our sponsors and thanked them for their generous support, highlighting the Federation, and how good they have been to our agency. She reviewed highlights of the year and emphasized how we are stronger together. She made a point of thanking all of her staff in helping to overcome the extra challenges presented this year. She then indicated how she was looking forward to the new year, and working with the new board and committees. Hanna thanked Alexis for her wonderful report.

**Audited Financial Statements**: Greg then took us through the audited financial statements highlighting major variances. He answered questions that arose, then moved, seconded by Carol, that the Audited Financial Statements be accepted as presented. Passed.

**Appointment of Auditor**: A motion has been made by Hanna, seconded by Cindy, that Vine and Partners, LLP be appointed our auditors for the next fiscal year. Passed.

**People leaving the Board**: Hanna referenced the three people not returning to the Board. She thanked Lisa for her many years of involvement, primarily in fundraising activities, and thanked David for his continuing to bring a smile to board members faces or a tune to their ears. Hanna then mentioned how much Joy had contributed this year, in so many ways, and will continue to do so, though not actually on the board.

**Board Members talk**: Each ongoing Board member then spoke for a brief time about their experiences on the Board, their primary interest in the agency and what they look forward to at the Board level.
