### APPROVAL OF THE AUDITED FINANCIAL STATEMENTS

Greg Matusovsky, Treasurer reviewed the abbreviated version of the 2022 financial statements prepared by Vine & Partners LLP on the audited statements of HJFS which include:

- statement of financial position as of March 31, 2022
- statement of operations (changes in fund balances and cash flow) as of March 31, 2022

The HJFS audit field work was done in June 2022. The Finance and Administration Audit Committee reviewed statements with the auditors in July and the Finance Committee approved the statements in August.

The HJFS budget increased by 13% over the previous year which represents about \$90,000 in fiscal year 2022.

### Income

- largest increase in our budget came from Hamilton Jewish Federation which represents 41%
- food bank donations and grants increased, but no United Way funding as in previous years

## **Expenses**

- higher costs in food bank costs both in food and in salaries which represents 39% of our expenses

Total funds in reserve at year end was \$290,639

2/3 thirds of this amount which is internally restricted is or the food bank

The externally restricted amount of \$67,110 is for the accessibility grant.

The official Audited Financial Statements prepared by Vine & Partners which were circulated prior to this meeting were viewed.

### **APPOINTMENT OF VINE & PARTNERS**

**MOTION**: To approve the appointment of Vine & Partners LLP as auditors for Hamilton Jewish Family Services for the upcoming fiscal year 2022/23 moved by Greg Matusovsky and seconded by Cindy Mark.

#### **RATIFICATION OF OPERATING BYLAWS:**

Hannah Schayer asked Gord Garshowitz to moderate this portion of the meeting as a member of the Governance Committee.

**MOTION:** To approve the Bylaws as distributed was moved by Gord Garshowitz and seconded by Carol Adler.

# Discussion on Section 8.1 (Members) of Bylaws

It was explained by Gord Garshowitz that the last time we had a valid constitution was in 2002. Many AGM's were held since then but not all members had been invited, so any changes in bylaws were not valid. Legal counsel was sought and in order to approve any changes in Bylaws, HJFS needed 50% plus one of our membership (351 members) to present at our last meeting held on September 6<sup>th</sup> which didn't happen so the Bylaws couldn't be approved.

Upon further reading of the 2022 Bylaws, a new legal option indicated five members would represent a quorum which why we called this meeting tonight.

Under the new bylaws Section 8.1 defines the only individuals considered members are Directors, Committee Members and current registered volunteers.

Gustavo Rymberg, CEO of Federation asked Gord Garshowitz to define the meaning of "registered volunteer" as listed in this section.

Gord Garshowitz explained that registered volunteers with HJFS are individuals who have registered with the Volunteer Coordinator and have met agency requirements including police checks.

Concern was expressed by Gustavo Rymberg that under the new bylaws Hamilton Jewish Federation will not be represented and have no voting status at future AGM 's of Hamilton Jewish Family Services. As Federation provides 41% of the operations budget it would be important to re-define who is a member. It is important to be inclusive and engage community members to be involved in decision making.

After a lengthy discussion, Les Lasky stated that this matter is too important to have a zoom discussion that is changing the constitution of HJFS. He suggested that a committee should be formed with members of HJFS and Federation to come up with a long term solution.

A motion should be made to table this for period of time (no longer than three months) at which time a committee has to come back to the board with a recommendation.

**MOTION**: To exclude Section 8.1 of the new Bylaws from the vote and that a Committee be formed to review this section and the rest of the new Bylaws be approved was moved by Les Lasky and seconded by Dina Honig.

MOTION APPROVED

Hannah invited individuals in attendance who wish to be part of the Section 8.1 revision to email Heather McLean.

When a resolution is reached on Section 8.1 a meeting of HJFS members (based on the 2002 version of Bylaws) will be called.
