The following changes were presented to be voted on:

Sections 4.3 - Eligibilty

Previous Wording

4.3 <u>Eligibility</u>. A Director shall be an individual eighteen (18) or more years of age, actively interested in furthering the purposes of the Corporation and, at the time of their election, is a Member of the Corporation as defined under 8.1(i). If possible, one or more of the directors shall be an individual, or a family member, with lived experience in one of the Corporation's priority areas of service.

Revised wording

4.3 Eligibility. A Director shall be an individual eighteen (18) or more years of age, actively involved in furthering the purposes of the Corporation and, at the time of their election, a Member of the Corporation as defined under 8.1.1. If possible, one or more of the directors shall be an individual, or a family member, with lived experience in one of the Corporation's priority areas of service.

Section 8.1 - Membership

Previous Wording

8.1 <u>Members</u>. The Membership shall consist of the directors of the Corporation, current members
of committees of the Corporation and currently registered volunteers with the Corporation. A
membership in the Corporation is terminated if the member fails to maintain at least one of the
qualifications for memberships described in this Section 8.1.

Revised Wording

• Members. The Membership shall consist of the following three groups:

- 8.1.1 The current directors of the Corporation, current members of committees of the Corporation and currently registered volunteers with the Corporation. These members are eligible to be directors under Section 4.3.
- 8.1.2 An individual who has, within the last fiscal year, made a donation to the corporation of \$18 or more that is eligible for a receipt for income tax purposes.
- 8.1.3 Hamilton Jewish Federation represented by one individual appointed by the Federation.
- 8.1.4 A membership in the Corporation is terminated if the member fails to maintain at least one of the qualifications for membership described in this Section 8.
